


#### **CARRIE JOHNSON**

Since 2010, Carrie Johnson has been a Justice Correspondent at National Public Radio. She covers a wide range of emerging justice issues, law enforcement stories, and legal affairs for the NPR programs Morning Edition and All Things Considered. In addition to her work at NPR, she also often moderates or appears as a panelist on legal panels for the American Bar Association, the American Constitution Society, the National Association of Criminal Defense Lawyers, and other organizations. She has discussed her work on CNN, MSNBC, Fox News, PBS, and other media outlets.



#### PROF. DR. ECKART BRÖDERMANN

Eckart Brödermann, trained in three jurisdictions, enjoys working on cross-border contracts and structuring international transactions. He has also been active in international arbitration proceedings around the globe for decades. Due to his deep understanding of different legal cultures he is a passionate ambassador for the simplification and standardization of international contracts. In his more than 25 years of practice since the firm was founded, Eckart Brödermann has focused on international transactions as well as international arbitration and litigation. Brödermann is a Professor of Law at the University of Hamburg and served for five years as an official observer to the shaping of the UNIDROIT Principles 2010 edition as well as being involved in the preparation of the UNIDROIT Model Clauses.




#### HONORABLE LEO M. GORDON

Judge Gordon began his career in public service over three decades ago as Assistant Counsel to the Subcommittee on Monopolies and Commercial Law, Committee on the Judiciary, U.S. House of Representatives. In that capacity, Judge Gordon worked on numerous legislative projects involving commercial and antitrust law, civil and constitutional rights, and court reform. He was the principal attorney responsible for the Customs Courts Act of 1980 that created the U.S. Court of International Trade the Article III Court having exclusive jurisdiction to review agency decisions relating to the collection and administration of duties and related areas. Judge Gordon served on the staff at the Court for 25 years, first as Assistant Clerk and then Clerk of the Court until his appointment to the bench in 2006. Judge Gordon graduated Phi Beta Kappa from the University of North Carolina-Chapel Hill and received his J.D. degree from Emory University School of Law.

#### LARRY FRIEDMAN

Larry's practice focuses exclusively on compliance with U.S. federal regulation of international trade including the collection of customs duties, the admissibility of merchandise, and export controls. Larry litigates before the U.S. Court of International Trade and the U.S. Court of Appeals for the Federal Circuit. He served as President of the Customs and International Trade Bar Associations and is a member of the adjunct faculty at the University of Illinois-Chicago Law School.




#### STEPHEN I. VLADECK

Stephen I. Vladeck is a professor of law at the Georgetown University Law Center, and is a nationally recognized expert on the federal courts, constitutional law, national security law, and military justice. Vladeck joined the GULC faculty in July 2024 after spending the first 19 years of his academic career at the University of Miami School of Law, American University Washington College of Law, and, most recently, the University of Texas School of Law. Vladeck is the author of the New York Times bestselling book, "The Shadow Docket: How the Supreme Court Uses Stealth Rulings to Amass Power and Undermine the Republic," which is a finalist for the 2024 ABA Silver Gavel Award for Media and the Arts.

#### **DANIEL GARRIE**

Daniel B. Garrie is a seasoned cybersecurity, computer forensics, e-discovery, and data privacy professional with over 25 years of experience in the field.
